**June 3rd, 2020 - one of the activities implemented to foster caregivers resilience in caring for dying patients is the pause the pause is a 15 to 30 second period of silence at the time of a patient s death shared by the team at the bedside the purpose is to honor the human life and the efforts of the team'**
